Abstract: Intuitive ideas in statistical causal inference and typical methods used in empirical economic analysis will be introduced, with some recent papers. Specifically, Randomized Control Trial, Natural Experiment, Regression Discontinuity Design, Instrumental Variable, and Difference-in-Differences will be discussed. Discussions will also be provided of problems and solutions for policy evaluation.
