

Abstract: In social sciences, most of researchers are interested in the causal effect of programs on outcomes. For example, an economist may be interested in uncovering the causal effects of a job-training program on earnings. Causal inference defines causal effects using the notion of potential outcomes and specifies assumptions under which one can identify causation from data. In this talk, I will provide a short lecture on causal inference in economics.
